Each individual user group will be responsible to abide by the following procedures and guideline for each scheduled use of municipal ice surface. User groups are to follow their own governing bodies operational plan.

- 1. The province of New Brunswick screening questionnaire process (https://www2.gnb.ca/content/dam/gnb/Departments/h-s/pdf/ScreeningEF.pdf) will be posed to every participant, coach, spectator regarding Covid-19 prior to entering the facility. If anyone answers yes to any of the questions in the questionnaire access will not be granted to enter the facility and should immediately follow the directions indicated on the questionnaire
- 2. User groups will collect contact information for all players, coaches, spectators and volunteers who are associated with each group booking to assist in any contract tracing. Each entrant of the facility shall register with name, ice surface, contact number and email to facilitate contact tracing should it be required by the health authorities.
- 3. While in the premises of the Bryon Dobson Arena a community face covering is required while entering and exiting the building, hallways, change rooms, washrooms and seating areas. Social distancing of one meter must be maintained with face covering on.
- 4. Participants will be directed to all entrances and exits of the facility. Signage will direct participants to and from their designated ice surface to control flow of patrons.
- 5. User Groups will only be permitted in the building 15 minutes prior to their ice time and must exit the building 15 minutes after their session. There will be no early admittance to the facility.
- Participants must come to the facility dressed in most of their equipment and ready for their activity.
- 7. Dressing rooms will be used as staging area to allow user groups to put on their skates and helmets and help with control of flow on and off the ice. Showers will be closed for the season.
- 8. User groups will stay in the dressing rooms until the other user group is off the ice surface and in their dressing room.
- 9. User groups are not permitted to store personal equipment on the premises.
- 10. User groups should sanitize equipment prior to and after their rental.
- 11. Participants will all use their own water bottles absolutely no sharing! Please fill at home.
- 12. Drinking fountains will not be available for use.
- 13. Please don't bring food into the arena. Beverages are only allowed if they are in reusable containers.
- 14. Only one parent or guardian will be permitted in the building with each participant. No siblings.
- 15. Upon entering the facility, the parent or guardian must go directly to the arena pad and remain in the stands in the marked viewing area in the stands.
- 16. Parents who need to assist their kids with skates can do so from front row of bleachers.
- 17. Entry and exit of the lower arena will be done only by the lower parking lot doors. Entry and exit of the upper arena will be done only by the upper doors on Biggs Drive.
- 18. Both upper and lower Mezzanines and Canteen are closed for the season.
- 19. Any individual who is not accompanying a child or who is not a coach will NOT allowed to enter the arena.
